TOPIC	Pickaway County Park District Grant
PRESENTED BY	Kay Swaney
DISCUSSION	Kay Swaney discussed filing a grant with the Pickaway County Park District for 2021. The grant would be for a new swing set for the Village Park. In addition, mulch for the playground area would be requested at an estimated cost of \$2350. The Village's match would be 10%. A resolution will be presented at the next Council meeting.

TOPIC	Village Gym Rental
PRESENTED BY	Kay Swaney
DISCUSSION	Ms. Swaney advised Council that the Westfall elementary wrestling program would like to rent the gym for practices. Ms. Swaney said Mayor Cox came up with a cost a few years ago to heat they gym in the winter. The cost was approximately \$75 per day. The Westfall wrestling program would like to use the gym from December to March. Ms. Swaney said the only conflict was the food pantry. The wrestling program would go in Monday morning, turn the heat on, and turn it off on Thursday. Marie Parrett will be consulted to see what the cost to heat the gym would be. Ms. Swaney said a cover would be put on the thermostat. Ms. Swaney asked if the Village could cover the cost of the heat bill. Councilperson Garrett stated the Village should wait until the estimates are figured. Councilperson Lyle said the Village might not be able to handle a heating bill of \$800 per month at the current time. Mayor Elliott said he would like to see the Village support the wrestling program. Ms. Swaney said she would send Council the amounts when she received them. Council will review the topic at the next meeting.

TOPIC	Handicap Parking Space
PRESENTED BY	Greg Hatfield

Mr. Hatfield updated Council on the situation with the handicap parking spaces in
front of the post office. The Village received a request for handicap parking
spaces at the post office. Mr. Hatfield spray-painted the lines on the street. Mr.
Tim Bush is the owner of the building and said the Village did not have permission
to install the handicap parking spaces. Mr. Bush called Mr. Hatfield to say that
the Village could not put a sign on his building or in the sidewalk in front of the
post office. Mr. Tony Ireland from Buckeye Pipe was with Mr. Hatfield when the
incident occurred. Mr. Ireland was present to mark the meters at the building.
Currently, the meters are inside the building. Mr. Bush denied Mr. Hatfield and
Mr. Ireland access to read the meters. Mr. Bush said the Village destroyed his
sidewalk. Joe Fenneken power washed the sidewalk to allow for the installation
of the handicap spaces. Mr. Hatfield will install a breakaway pole with the
handicap sign. Mr. Hatfield called the Pickaway County Sheriff's Department due
to Mr. Bush making physical contact. The Sheriff advised the Village should send
a certified letter to Mr. Bush advising him of the installation of the parking spaces.
Mayor Elliott advised that Mr. Bush does not own the sidewalk. Councilperson
Lyle said Mr. Hatfield needs something in writing saying what is going to happen.
Mayor Elliott said the Village must have access to the meters to read them. If Mr.
Bush wants them moved to the outside it will be at his expense. Councilperson
Lyle said a letter with a cost to move the meters should be sent to Mr. Bush. The
Mayor will draft a letter for the installation of the parking spaces and the cost for
the meter move and send it to Mr. Bush. Councilperson Lyle said Mr. Hatfield
should not go to the location alone.
