While having training with Greg and Marie on the new Badger Beacon Software, we had some issues with the Toughbook laptop currently being used for reading water meters. The touch screen on the computer is very hard to work with. We found we had to tap the screen multiple times and very aggressively for it to respond. The laptop as well does not have to full capability of showing some features such as the meter reader moving on the screen while reading meters. This shows that the GPS installed in the laptop is old software and holding the meter reader back from fully doing his job in a timely manner. I understand during our meeting when I presented all the software and reading device that the village decided to stay with the old laptop. I fully agree with that decision but upon training noticing the issues with the laptop it is in the best interest to purchase a new reading device. Now I am in no way trying to simply make an extra dollar. My main interest is the customer and how they can do the job in a timely manner. The new tablet would be a Trimble T10 Tablet. This is a very well built I-Pad so to speak. It will come with a 3 year warranty as well. Please consider this new device for the village as you move forward in the future while reading meters.
